**GOVERNMENT’S RESPONSE TO
COURT’S ORDER OF JULY 16, 2002**

In compliance with this Court’s Order of July 16, 2002, with regard to defendant’s outgoing mail, following is a list of letters reviewed by, or being reviewed by, the Federal Bureau of Investigation, and their present status. According to the FBI, defendant began writing letters immediately before the July 4th holiday period, which caused a slight delay in the development of procedures for handling his outgoing mail.
